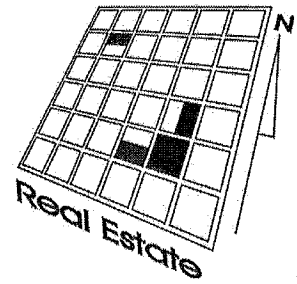

The assessor has discovered an error in the 2017 assessed value of parcel number 201.0121.000, located at 201 4th St N., owned by Maurina Funeral Service

Ms. Lopez contacted our office when she received a call from Kevin, the owner, questioning the assessed value of his improved value. Kevin explained to Ms. Lopez that the building had been razed before January of 2017 and it was asphalt only. The assessor was not aware of this until Ms. Lopez contacted the assessment office. The assessor never had received the permit stating that the building was being razed. Consequently, the subject was not fielded.

The original 2017 assessment was \$47,200, land \$17,200 and improved value 30,000. The correct assessment for 2017 should be, land \$17,200 and improvement \$5,000 (for the asphalt), for a total assessed value of \$22,200 . Therefore, the total overage in assessed value is \$25,000.

This assessment error qualifies as a "palpable error" under Wisconsin Statutes 74.33 and is therefore subject to refunded or rescinded taxes.

The procedure for refunding or rescinding property tax is described in Wisconsin statutes, chapters 70.43 and 74.41. Essentially, the City should pay the difference in taxes due, and then the City can apply to have the tax money refunded by way of a "charge back" through the Department of Revenue.
